

Privacy Policy

Information sharing

Personal information and patient data will not be shared by Pulse-right with external companies or individuals outside of the Pulse-right organization.

Information security

We enforce appropriate security protocols to safeguard against unauthorized access, modification, disclosure, or loss of data. These protocols involve internal evaluations of our data collection, storage, and processing methods, along with security measures such as choosing trustworthy infrastructure providers, utilizing username and password authentication, employing two-factor authentication, and implementing data encryption when required.

Only Pulse-right employees, contractors, and agents with a legitimate need for personal information are granted access to it. These individuals are bound by confidentiality obligations and may face disciplinary consequences, including termination and possible legal prosecution, if they do not fulfill these obligations.

Accessing and updating personal information

As you utilize Pulse-right services, While using Pulse-right services, we strive to provide you with access to your personal information and, if needed, correct any inaccuracies or delete the data at your request. However, certain legal obligations or legitimate business requirements for data retention may limit these actions. To handle such requests, we kindly ask individual users to confirm their identity and specify the desired access, correction, or removal of information. It's important to note that we may decline requests that are unreasonably repetitive, systematic, excessively burdensome from a technical perspective, jeopardize others' privacy, or are highly impractical (such as requests involving information stored on backup tapes) and not essential for access purposes.

We offer access and correction of information free of charge, unless it would entail excessive efforts. However, please be aware that certain services may retain residual copies of information on active servers and backup systems even after deletion. How you can access your personal information

When you log into your account, you can access specific personal information that we have gathered about you. Furthermore, you have the right to request access to other personal information we have in our possession and to request corrections for any inaccuracies in that data.
